### DIRECTIONS FOR USE:

Applications	Rates and Comments
<b>Tees and Greens</b>	Apply 6 oz per 1,000 square feet for initial application. Apply in split applications of 3 ounces every 14 days for subsequent applications or in monthly single applications of 6 oz per 1,000 sq. ft. Apply in 2 gallons of water per 1,000 sq.ft.
<b>Fairways, Lawns, Athletic Fields</b>	Apply 2 gallons per acre in a minimum of 90 gallons of water monthly.

### First Aid Measures:

**Eye Contact:** Do not rub eyes. Immediately flush eyes with large amounts of water for 15 minutes. Seek medical attention

**Skin Contact:** Remove contaminated clothing and immediately wash affected area with water for at least 5 minutes. If irritation or redness persists, seek medical attention

**GENERAL:** **Turf Wet Select™** is a blend of an advanced polymer and solvent chemistry. This chemistry is designed to support a uniform wetting and rewetting characteristic while providing a consistent penetration. **Turf Wet Select's** formulation delivers fast hydration, and reduces excessive moisture. It is use of two advanced surfactants that provide the ultimate playing surface. Recommended where tournament/game day conditions are demanded, golf courses, athletic fields, tennis, lawn bowling and other grass sporting fields.

**Turf Wet Select**, with its aggressive formula, improves moisture distribution in a variety of sand and non-sand based soil types relieving the effects severe stress conditions. When applied in a program prior to the onset of hydrophobic conditions, it will prevent their effects. **Turf Wet Select** will enhance rooting and overall turf vigor when used in monthly programs.

**Turf Wet Select** provides an efficient that improves irrigation use and water savings.

**DIRECTIONS FOR USE:** Greens, Tees, Fairways, Lawns, Parks and Sports Turf

**Standard Program:** Apply 4-6 fl oz. of **Turf Wet Select** per 1000 sq. ft. in 2 gallons of water (185 mL/100 m2 in 8 L of water). Apply monthly, beginning at least one month prior to the onset of stress conditions. Irrigation should be applied before next mowing to enhance product movement into the soil.

**Weekly & Biweekly Program:** Initial application; apply 4-6 fl oz. of **Turf Wet Select** per 1000 sq. ft. in 2 gallons of water (185 mL/100 m2 in 8 L of water). After initial applications, apply weekly at 1 fl oz per 1000 sq ft, or biweekly at 2-3 fl oz. per 1000 sq ft. Initial 4-6 fl oz. applications are critical to maintaining a weekly or biweekly program.

**Tank Mixing:** **Turf Wet Select** may be tank mixed with other commonly used turf chemicals and fertilizers at rates not to exceed 6 oz per 1000 sq. ft. If applicator is unfamiliar with the performance of this product in tank mixes under user's growing conditions, **Turf Wet Select** should be tested prior to large-scale application. The applicator should always exercise judgment and caution when using this and all other turf products. Tank mixing **Turf Wet Select** other products is intended as a matter of convenience; this product is not intended to enhance the performance of other tank mixed components.

### PRECAUTIONARY STATEMENT
