## DIRECTIONS FOR USE:

Applications	Rates and Comments
<b>Split application</b>	Apply 8 oz per 1,000 square feet. Wait 7-10 days and reapply a second application of 8 oz per 11,000 sq feet. Apply both applications in a minimum of 2 gallons of water per 1,000 sq ft. Read back label for entire directions for use.
<b>Single application</b>	Apply 16 oz per 1,000 square feet in a minimum of 5 gallons of water per 1,000 square feet as a stand-alone application. Read back label for complete directions for use.

### First Aid Measures:

**Eye Contact:** Do not rub eyes. Immediately flush eyes with large amounts of water for 15 minutes. Seek medical attention.

**Skin Contact:** Remove contaminated clothing and immediately wash affected area with water for at least 5 minutes. If irritation or redness persists, seek medical attention.

**If Swallowed:** Give large amounts of water to drink. Seek medical attention if necessary. Induce vomiting only upon advice from a physician.

**Inhalation:** Move affected individual to fresh air and check to assure adequate respiration. Seek medical attention if necessary.

Turf Wet LT Select™ will help prevent localized dry spot conditions from forming when used early in the season or before water repellency conditions appear. Turf Wet LT Select flexible application regiment, provides operators a variety of application options to fit their spray program. Turf Wet LT Select is safe on all turf. When applied according to label directions Turf Wet LT Select will not burn.

**DIRECTIONS FOR USE:** Greens, Tees, Fairways, Lawns, Parks and Sports Turf

**Split Application:** Apply first application at 8 fl. oz. per 1,000 sq. ft. Apply second application 7-10 days later. When treating with 2 split applications, Turf Wet LT Select should be sprayed at 8 fl. oz. per 1,000 sq. ft. and should be applied in 2 gallons of water per 1,000 sq. ft. spray solution.

**Single application:** Turf Wet LT Select can be applied in a single stand-alone application of 16 ounces per 1,000 sq.ft. in a minimum of 5 gallons of water per 1,000 sq. ft.

TURF WET LT SELECT is safe on all turf types and can be used on fine turf for golf courses, athletic fields, tennis, lawn bowling, sporting fields as well lawns/landscape.

**Tank Mixing:** Turf Wet LT Select may be tank mixed with other commonly used turf chemicals and fertilizers at rates not to exceed 8 fl. oz. per 1000 sq. ft. If applicator is unfamiliar with the performance of this product in tank mixes under user's growing conditions, Turf Wet LT Select should be tested prior to large-scale application. The applicator should always exercise judgment and caution when using this and all other turf products. Tank mixing Turf Wet LT Select and other products is intended as a matter of convenience; this product is not intended to enhance the performance of other tank mixed components.

## PRECAUTIONARY STATEMENT
